## <u>F CLASS MEETING 10<sup>TH</sup> – 13<sup>TH</sup> SEPTEMBER 2020</u> COVID-19 RISK ASSESSMENT

This Risk Assessment will be reviewed and revised in light of any material changes to Government Covid-19 guidelines.

If you are feeling unwell or have Covid-19 symptoms please do not visit the National Shooting Centre, no matter how mild the symptoms. If you are displaying symptoms yourself you must isolate for 10 days. If you are sharing a household with someone who is displaying symptoms you must isolate for 14 days.

#### AIM

- 1. The aim of this Risk Assessment is to identify existing and potential Covid-19 transmission hazards associated with competition range usage at the National Shooting Centre (NSC) and to demonstrate that the appropriate control measures, in accordance with Government guidance, are in place. General mitigation, in all areas will include:
  - Social distancing
  - Spaced queuing systems
  - Frequency and availability of hand washing and surface cleaning
  - Enhanced cleaning regimes for shared / common facilities

### **ACTIVITIES**

- 2. The primary activity is competitive target shooting. This assessment will include competitor's arrival at the NSC processing through reception, operating procedures for scorecards and stats teams, the occupation and use of the ranges by competitors, Range Officers, markers and other support members, as well as NSC facilities.
- 3. The NSC team will provide support and advice upon the revised procedures and social distancing throughout.
