## Target Shotgun Skills Course Event Notes

Saturday 24<sup>th</sup> February 2024

- **Entry Fee:** £92.50, £55.50 for those that are under 25 years old on the day of the event
- **Meeting Membership:** £10.50
- **Firearm & Ammunition usage:** £58.00
- **Entry Deadline:** Monday 19<sup>th</sup> February at midday
- **Cancellations:** Cancellations must be received via email to [competitions@nra.org.uk](mailto:competitions@nra.org.uk) by **8am Thursday 22<sup>nd</sup> January**. Entries will be fully refunded (or credited) before this time, after this point entries are non-refundable. Credits are valid for 12 months from the date of cancellation
- **Aims & Objectives:** This Skills Development Day will provide you with the fundamental skills for taking part in Target Shotgun (TS) events and competitions. The day comprised of both classroom and practical range work, with expert coaching from national and international level shooters on topics including types of firearms, equipment and positional shooting techniques. In the morning session you will cover Target Shotgun (TS) Classes, firearm types, kit and equipment, positional techniques, revise the principles of marksmanship, and Target Shotgun events run by the NRA
- **Entry Requirement Summary** (*See Terms of Entry below for full details*):
  - ✓ **Shooter Certification Card (SCC):** Each civilian shooting on a MoD or NRA range has to carry a SCC issued by the chairman of a club of which they are a member and which is affiliated to the NRA. Attendees **MUST** be in possession of their SCC when shooting on NRA ranges
  - ✓ This event is open to members of Home Office Approved Clubs (HOAC) who are not prohibited under section 21 of the Firearms Act (The NRA is the largest HOAC in the UK)
  - ✓ Non-NRA members are welcome but are required to pay the Meeting Member Fee
  - ✓ On the first day of the event you must be aged 14 or over (please contact the event Co-ordinator before entering if this is not the case)
- **Making an entry:** Entries can be made and paid for online via: [online.nra.org.uk](http://online.nra.org.uk). A downloadable paper entry form will also be available which can be returned via email or post.
- **Firearms & Ammunition:** These are not included in the Skills Day fee, attendees are encouraged to bring their own. If not yet in possession of a suitable firearm attendees can have use of an NRA Target Shotgun for the day, and purchase sufficient ammunition, both will be issued on the range by the Instructor

**Section 1 shotguns** are generally any magazine-fed shotgun with a capacity of more than 2 rounds or a detachable magazine, and are the most competitive type available for Target Shotgun shooting. They may only be used by a person with the relevant conditions on their FAC. It is not permitted to borrow or loan a shotgun to which Section 1 of the Firearms act applies.

**Section 2 shotguns** are generally any shotgun with a fixed magazine of no more than 2 round capacity or a classic type shotgun with 2 barrels. They are the most prevalent type available however their use in TS is severely limited and, although useful for training beginners, are not suitable to be used in most TS competitions.
- **Muzzle Energy:** Ranges at Bisley use the Danger Area of Pirbright Range, which under MoD requirements state that all firearms used must either have a muzzle energy under 4,500 Joules (3,319 ft lbs), or else be zeroed at 200 yards or on the Bisley Zero Range prior to being used at a longer distance. If your ME exceeds the limit then you must zero your rifle, using the specially designed target, the day before the start of your particular Meeting
- **Firearms Usage:** The NRA is required to keep a record of firearms used by competitors as required by the Firearms (Amendment) Acts 1997. Following an NRA Event please go to your online profile and update your firearms usage: [online.nra.org.uk/customer/firearmusages](http://online.nra.org.uk/customer/firearmusages)
- **SCC Assessment:** If you are an NRA Member and wish to add "Target Shotgun" to your SCC you can undertake an assessment during the course. There is no additional fee, but you will need to advise us when booking that you would like to do the assessment

Non-members can take the same assessment and will be presented with a certificate of attendance. Your Club Chairman may then decide to authorise "Target Shotgun" to be added to your SCC

The TS Handbook is a great source of information, it contains descriptions of TS Classes, Positional Techniques, Rules and Event courses of fire. As well as being available online, a FREE paperback book can be collected from NRA Reception

- **Dress & Equipment:** Attendees should bring warm weatherproof clothing and appropriate footwear in case of inclement weather. You will need:
  - Safety glasses & Ear defenders
  - Firearm - a magazine-fed shotgun (tube or box) either S1 or S2\*
  - Approximately 100 rounds of Birdshot (size UK 4/5/6/7/8) and 30 slug - Fibre Wad Only (if permitted to possess on FAC)
  - Cartridge belt (NRA has a limited number available for use)
  - Normal shooting equipment
  - Notebook and pencil

\*Under the Firearms Act you are NOT permitted to borrow or use a high-capacity firearm or solid slug ammunition without possessing a firearms licence that permits you to possess such items

Please be advised that you will be shooting prone and the ground may be muddy. Assistance in resetting targets and clearing spent cases is mandatory

#### **Terms of Entry:**

- I agree I meet the entry criteria as stated in these Event Notes
- I confirm that the information given on the attached Entry Form is true, complete and accurate

#### **Access to firearms:**

- I meet at least one of the following conditions that legitimise my access to firearms:
  - I am an individual member of the NRA
  - I make this declaration as a participant in an NRA Guest Day
  - I hold a Firearm Certificate or GB Visitor's Firearm Permit permitting me to use, for target shooting, the firearms that I shall fire in this event
  - I am a member of a Club Approved by the Home Office, the Scottish Ministers or the PSNI and will be shooting as a member of that club and will use any firearm for which I do not hold a Firearm Certificate only in accordance with the applicable exemptions to S1 Firearms Act 1968 as amended
- I am not a prohibited person within the meaning of Section 21 Firearms Act 1968 (as amended)
- I have never had a Firearm or Shotgun Certificate refused or revoked. (If you have, please enclose full details in a sealed envelope marked 'Confidential')

#### **Eligibility**

- On the first day of the Event I will be aged fourteen years or over; OR I have the written approval of the NRA and the Event director to participate notwithstanding my age.
- I certify that I am qualified to participate in accordance with the Regulations and hold a current certificate of Safety and Competence, which I will present at the Event
- I am an individual member of the NRA; or by virtue of at least one of the following I meet the criteria to be granted, and I apply for, temporary membership of the NRA for the duration of the Event:
  - I hold a UK Firearm Certificate, GB Visitor's Firearm Permit or Permit under S7 Firearms Act 1968 authorising possession of a full-bore rifle, small-bore rifle or muzzle-loading pistol
  - I am a full member of a club Approved by the Home Office, the Scottish Ministers or the PSNI
  - I am a present member of HM Forces and have current military certification of competence with a full-bore rifle

#### **Warnings:**

- I agree that I have been warned that ear protection must and eye protection may be required to be worn at all times in the vicinity of all firing points while shooting is in progress, and shall not hold the organiser responsible for

any injury resulting from non-compliance therewith. Any mandatory details will be contained within the specific Event Notes for each Event

- I agree to abide by the rules of the National Rifle Association and of the Event and I will accept the decisions of the Event Director or the NRA as final
- I agree that results of a Competition and classifications may be published on the internet or elsewhere containing my name, competitor number, class and score
- I understand that if I have debts to NRA or NSC Ltd over 90 days outstanding, squadding cards will not be issued to me until these have been settled in full
