General Event Information:

- Entry Requirement Summary (See Terms of Entry below for full details):
 - ✓ **Shooter Certification Card (SCC):** Each civilian shooting on a MoD or NRA range has to carry a SCC issued by the chairman of a club of which they are a member and which is affiliated to the NRA. Attendees MUST be in possession of their SCC when shooting on NRA ranges. For our Skills Courses you are only required to have a valid SCC, it does not need to contain the type of firearm you will be using
 - ✓ This event is open to members of Home Office Approved Clubs (HOAC) who are not prohibited under section 21 of the Firearms Act (The NRA is the largest HOAC in the UK). Non-NRA members are welcome, but are required to pay the Meeting Member Fee
 - ✓ On the first day of the event you must be aged 14 or over (please contact the event Co-ordinator before entering if this is not the case
- Making an entry: Entries can be made and paid for online via: <u>online.nra.org.uk</u>. A downloadable paper entry form will also be available which can be returned via email or post.
- **Firearms & Ammunition:** These are not included in the entry fee, attendees are expected to bring their own. If not yet in possession of a suitable firearm attendees can have use of an NRA scoped Ruger 10/22 rifle for the day, and purchase sufficient ammunition, both will be issued on the range by the Instructor. For GR&P any of the following types of firearms will be suitable for the event:
 - o Gallery Rifle Centrefire (GRCF)
 - GRCF Standard: a lever action rifle with an integral tube magazine
 - GRCF Open: any other Gallery Rifle of different design
 - o Gallery Rifle Smallbore (GRSB): Any Gallery Rifle in .22" rimfire may be used. The standard for GRSB is a self-loading rifle with a detachable magazine. Other designs are permitted
 - Long Barrelled Pistol (LBP): Any .22" rimfire Long Barrelled Pistols including revolvers and self-loading guns
 - o Long Barrelled Revolver (LBR): Any Long Barrelled Revolver in a centrefire pistol calibre

If you do not have your own firearm you may hire one for the purpose of the course

- **SCC Assessment:** If you are an NRA Member and wish to add "Gallery Rifle/Carbine" to your SCC you can undertake an assessment at the end of the skills day. There is no additional fee, but you will need to advise us when booking that you would like to do the assessment
 - Non-Members can take the same assessment, and will be presented with a certificate of attendance. Your Club Chairman may then decide to authorise "Gallery Rifle/Carbine" to be added to your SCC
- **GR&P Useful Information:** The GR&P Handbook is a great source of information. It contains descriptions of GR&P Classes, Positional Techniques, Rules and Event courses of fire. The GR&P Handbook can be found <u>online</u> and in a FREE paperback book available from NRA Reception

- Muzzle Energy: Ranges at Bisley use the Danger Area of Pirbright Range, which under MoD requirements state that all firearms used must either have a muzzle energy under 4,500 Joules (3,319 ft lbs), or else be zeroed at 200 yards or on the Bisley Zero Range prior to being used at a longer distance. If your ME exceeds the limit then you must zero your rifle, using the specially designed target, the day before the start of your particular Meeting
- **Firearms Usage:** The NRA is required to keep a record of firearms used by competitors as required by the Firearms (Amendment) Acts 1997. Following the Course please go to your online profile and update your firearms usage: online.nra.org.uk/customer/firearmusages
- **Dress & Equipment:** Attendees should bring warm weatherproof clothing and appropriate footwear in case of inclement weather. Light Gore-Tex jackets are recommended with under layers according to the weather, and suitable lightweight walking-type trousers with waterproof over trousers if required. Please be advised that you will be shooting standing, sitting and kneeling, and the ground may be muddy. Jeans and heavy cotton trousers are not suitable. You will need:
 - o Ear defenders
 - o Firearm
 - o Ammunition: Approximately 200 rounds
 - o Normal shooting equipment
 - Notebook and pencil

Terms of Entry:

- I agree I meet the entry criteria as stated in these Event Notes

Access to firearms:

- I meet at least one of the following conditions that legitimise my access to firearms:
 - o I am an individual member of the NRA
 - o I make this declaration as a participant in an NRA Guest Day
 - o I hold a Firearm Certificate or GB Visitor's Firearm Permit permitting me to use, for target shooting, the firearms that I shall fire in this event
 - o I am a member of a Club Approved by the Home Office, the Scottish Ministers or the PSNI and will be shooting as a member of that club and will use any firearm for which I do not hold a Firearm Certificate only in accordance with the applicable exemptions to S1 Firearms Act 1968 as amended
- I am not a prohibited person within the meaning of Section 21 Firearms Act 1968 (as amended)
- I have never had a Firearm or Shotgun Certificate refused or revoked. (If you have, please enclose full details in a sealed envelope marked 'Confidential')

Eligibility

- On the first day of the Event I will be aged fourteen years or over; OR I have the written approval of the NRA and the Event director to participate notwithstanding my age.
- I certify that I am qualified to participate in accordance with the Regulations and hold a current certificate of Safety and Competence, which I will present at the Event
- I am an individual member of the NRA; or by virtue of at least one of the following I meet the criteria to be granted, and I apply for, temporary membership of the NRA for the duration of the Event:
 - o I hold a UK Firearm Certificate, GB Visitor's Firearm Permit or Permit under S7 Firearms Act 1968 authorising possession of a full-bore rifle, small-bore rifle or muzzle-loading pistol
 - o I am a full member of a club Approved by the Home Office, the Scottish Ministers or the PSNI
 - o I am a present member of HM Forces and have current military certification of competence with a full-bore rifle

Warnings:

- I agree that I have been warned that ear protection must and eye protection may be required to be worn at all times in the vicinity of all firing points while shooting is in progress, and shall not hold the organiser responsible for any injury resulting from non-compliance therewith. Any mandatory details will be contained within the specific Event Notes for each Event
- I agree to abide by the rules of the National Rifle Association and of the Event and I will accept the decisions of the Event Director or the NRA as final
