## CSR Imperial Falling Plates Event Notes

Saturday 6<sup>th</sup> July 2024 | Stoney Castle Range

- **Programme & Fees:**

- **Saturday:** Falling Plates - **£18/ team**

- **Under 25 Discount:** 40% discount off entry fee when all members of the team are under 25 years old on the day of the Event

- **Meeting Membership:** £14.50 per person – not applicable if Meeting Membership has already been paid for an Individual CSR Imperial Entry

- **Entry Deadline:** Monday 1<sup>st</sup> July at midday

- **Cancellations:** Cancellations must be received via email to [competitions@nra.org.uk](mailto:competitions@nra.org.uk) by **8am Thursday 4<sup>th</sup> July**. Entries will be fully refunded (or credited) before this time, after this point entries are non-refundable. Credits are valid for 12 months from the date of cancellation

- **Entry Requirements:**

- ✓ **Shooter Certification Card (SCC):** Each civilian shooting on a MoD or NRA range has to carry a SCC issued by the chairman of a club of which they are a member and which is affiliated to the NRA. Competitors MUST be in possession of their SCC when shooting on NRA ranges. If you do not have an SCC for the type of firearm you wish to participate with please contact the Competition Co-ordinator before entering
- ✓ This competition is open to members of Home Office Approved Clubs (HOAC) who are not prohibited under section 21 of the Firearms Act (The NRA is the largest HOAC in the UK). Non-NRA members are welcome, but are required to pay an additional Meeting Member Fee
- ✓ On the first day of the Competition you must be aged 14 or over (please contact the Competition Co-ordinator before entering if this is not the case)

- **Making an entry:** Entries can be made and paid for online via: [online.nra.org.uk](https://online.nra.org.uk). A downloadable paper entry form will also be available which can be returned via email or post

- **Falling Plates Classes:**

- Modern: Any pattern designed from 1955 to present
- Historic: *In abeyance 2024*
- Open: Any iron or scoped 5.56mm rifle. The course of fire will include a reduced 25 yard rundown, and all rifles must be shot prone unsupported – i.e. the use of bipods or a magazine to rest the firearm is prohibited

- **Courses of Fire:** Conditions and courses of fire are listed in the CSR Handbook which can be found [online](#) and in a FREE paperback book available from NRA Reception

- **Firing Positions:** Prone, sitting, kneeling and standing. Para A3.2.22 of the CSR Handbook: A firer who has a physical disability (temporary or permanent) which prevents the use of a position specified in the match conditions may assume the next most difficult position instead. The CRO, RO and the MD must be informed before the start of the match. The following substitutions are among those permitted:

- a. The sitting position instead of the prone position
- b. The kneeling position instead of the sitting position
- c. The standing position instead of the kneeling position
- d. The kneeling unsupported position (either on two knees or on one knee without resting the elbow on the knee) instead of the standing position

- **Muzzle Energy:** Ranges at Bisley use the Danger Area of Pirbright Range, which under MoD requirements state that all firearms used must either have a muzzle energy under 4,500 Joules (3,319 ft lbs), or else be zeroed at 200 yards or on the Bisley Zero Range prior to being used at a longer distance. If your ME exceeds the limit then you must zero your rifle, using the specially designed target, the day before the start of your particular Meeting

- I meet at least one of the following conditions that legitimises my access to firearms:
  - I am an individual member of the NRA
  - I make this declaration as a participant in an NRA Guest Day
  - I hold a Firearm Certificate or GB Visitor's Firearm Permit permitting me to use, for target shooting, the firearms that I shall fire in this event
  - I am a member of a Club Approved by the Home Office, the Scottish Ministers or the PSNI and will be shooting as a member of that club and will use any firearm for which I do not hold a Firearm Certificate only in accordance with the applicable exemptions to S1 Firearms Act 1968 as amended
- I am not a prohibited person within the meaning of Section 21 Firearms Act 1968 (as amended)
- I have never had a Firearm or Shotgun Certificate refused or revoked. (If you have, please enclose full details in a sealed envelope marked 'Confidential')

### Eligibility

- On the first day of the Event I will be aged fourteen years or over; OR I have the written approval of the NRA and the Event director to participate notwithstanding my age.
- I certify that I am qualified to participate in accordance with the Regulations and hold a current certificate of Safety and Competence, which I will present at the Event
