

Target Rifle Imperial Meeting 2020 COVID-Secure Procedures









All competitors, officials and spectators must undergo a self-assessment for any Covid-19 symptoms before travelling to the National Shooting Centre (NSC). No one should leave home to participate in the Meeting if they, or someone they live with, has symptoms of Covid-19, currently recognised as any of the following:

- A high temperature
- A new, continuous cough
- A loss of, or change to, their sense of smell or taste

If you are feeling unwell or have Covid-19 symptoms, please do not visit the National Shooting Centre (NSC), no matter how mild the symptoms. The NSC has put in place COVID-Secure procedures throughout the camp. Please adhere to the various notices and instructions. We respectfully ask that you maintain social distancing at all times, and practice regular hand hygiene throughout your time on site

If you start experiencing symptoms during the Meeting you must:

Follow Current Govt Covid Guidance

Any changes to Covid-Secure Procedures will be publicised via Notice Boards, CRO announcements and email to competitors

General:

- Please adhere to new signage on site with particular regards to social distancing and hand hygiene
- Hand sanitising stations will be positioned in public areas and on the range
- Social distancing will be in place throughout the site
- Should a competitor become ill during the Meeting, they must immediately self-isolate and inform the NRA via phone or email. The NRA will assess the circumstances and publicise any revisions to Procedures

Entering a Competition:

- All individual and team matches are available to be booked online via <u>online.nra.org.uk</u>; we encourage you to use this method to reduce the use of paper entry forms
- Payment for entries should be made online. Where this is not possible, payment may be made over the phone in advance of arrival. Exceptionally, card payments may be made on arrival at Bisley for any amount (contactless up to £45, or contactless Apple Pay with no spending limit). Cash payments will not be accepted

Collecting Entry Packs from Reception:

- All competitors must report to Reception to conform with track and trace requirements and collect their entry pack. A queuing system will operate and floor markings will indicate waiting / serving positions. Please wait until a space becomes available before entering the building
- Face coverings are to be worn in the Reception building, unless excused due to a medical condition
- Perspex screening has been installed in the Reception area
- Staff will wear suitable PPE when handling competitor packs. Packs will be assembled at least 72 hrs in advance and quarantined

On the Range:

- Ammunition for individual events will be issued on range before each competition by NRA staff using PPE. A one way social distancing layout will be implemented. Note: the properties of brass are such that bacteria and viruses are quickly destroyed; thus transmission risks from handling ammunition are very low
- Hand sanitising stations will be available behind the firing point on all ranges
- Competitors must adhere to social distancing at all times. Line markings behind the firing point will indicate 'Current Detail' and 'Waiting Detail' in order to segregate competitors
- Competitors should be present in the 'Waiting Detail' area behind their allotted firing point no later than 15 minutes before the start time of the detail. They may only more forward once the 'Current Detail' are clear
- Squadding Notices will indicate the target number; scramble boards will not be used
- Competitors will be squadded 2 per target, and will decide between them who is to take the left and right position. Where possible, left-handers should take up the right side position on the firing point
- Where a competitor is squadded on their own, the RO will nominate an individual to complete the counter scorecard (see below)
- Markings on each firing point will indicate the head position of the prone shooter in order to ensure social distancing
- New scorecards have been designed to ensure that competitors do not need to swap cards for the purpose of
 confirming scores. Competitors will record both their own score and that of the other shooter on the same
 card. The competitor will sign to confirm <u>both</u> scores, and stats will verify that the two cards match
- Each competitor must deposit the completed scorecard into the collection box, located on each Butt, when leaving the point
- A pen will be provided in entry packs; pens are not to be shared between competitors
- If a competitor requires the attention of a Range Officer they must raise their hand and wait NO CALLING OR SHOUTING IS PERMITTED, unless in an emergency
- Competitors are not allowed to share firearms or any range equipment, other than with those in their household
- Returned Sighters will be checked and deposited under control of the RCO
- **Team Matches** procedures for team competitions will be published separately

Firing Point Safety: THIS IS A CHANGE TO THE UNLOAD DRILL AND IS MANDATORY BOTH FOR RANGE SAFETY AND AS A COVID-SECURE PROCEDURE

- Competitors will be responsible for clearing their own firearm before leaving the firing point. Competitors must witness each other to confirm the following procedure has been conducted correctly:
 - On completion of the match or distance each competitor, in turn, will unload their firearm and perform a three point visual check to confirm no rounds are present:
 - On the face of the bolt
 - In the chamber
 - In the action
 - Once verified, the competitor must remove the bolt and confirm a clear view through the chamber and barrel. The competitor must then declare in an audible voice to the other competitor, "Clear"
 - The rifle must only be removed from the firing point with the bolt removed and / or breech flag inserted

Range Officers (ROs):

- ROs will be supplied with PPE kits should they need to approach a competitor in close proximity, which will consist of nitrile-based gloves and face mask
- Trigger weights will be issued to each RO. ROs will place the weight on the table for competitors to weigh their trigger. The procedure for any failed triggers will be controlled by the RO
- ROs will collect their radios in zip lock bags in accordance with separate Range Office procedures. They are <u>not</u> to be removed from the bag. Sanitiser and alcohol wipes will be used between any changes
- Only the CRO will have control of a range tannoy system

Special Duties:

- Wing / Range Officers will be issued PPE by the CRO when reporting for duty. This will consist of nitrile-based gloves and face mask should they need to approach a competitor in close proximity
- Competitor Wing / Range Officers will not be issued with Hi-Viz tabards in order to reduce shared equipment

Stats:

- During the Meeting, stats will operate from the meeting room at the back of the Main NRA building. No competitors will be permitted inside the stats room
- Stats queries should be made via email to: stats@nra.org.uk
- Exceptionally, queries may be made via the side window social distancing measures will be in place

Results:

- Links to results will be available online via www.nra.org.uk/liveresults throughout the Meeting
- Hard copy results lists will be published on the Stats Boards to the side of the Main NRA building, suitably spaced to avoid crowding

Prize Giving:

- A Prize giving ceremony for the major prizes will be arranged for Saturday 19th September in the Pavilion
- An awards table will be laid out and all trophies / medals sanitised and quarantined prior to the ceremony
- Recipients will be called forward to collect their awards. The prize presenter will not shake hands
- Trophy receipts will be prepared in advance. Recipients must bring their own pen to sign the receipt (the NRA will have spare pens and sanitisers available)

Ablutions & Toilet facilities:

All site ablutions and toilet facilities will have enhanced cleaning regimes in line with Government guidelines

Food & Beverages:

 On-site food and beverage outlets will open in line with Government advice. Please check the NRA news page for scheduled re-opening dates

Accommodation:

Clubhouses:

• We recognise that socialising is a vital part of the Meeting; however, Government guidance must be followed at all times

Cancellation / Withdrawal of entry:

• Cancellations up to 48 hours will be fully refunded. If withdrawing during the Meeting, entries for the day of cancellation, and the next day, will be fully charged
