

## **Adaptive Championship 2025**

Thursday 19<sup>th</sup> June

Event Notes

**Entry Fee:** Entry is FREE for all competitors, and will include a buffet lunch provided by our sponsors **Entry Requirements:** 

- ✓ The Championship is open to any injured Serving or Veteran Service personnel from British or Overseas Forces
- ✓ Competitors do not need to be members of the NRA or affiliated clubs, but are required to sign a section 21 declaration prior to shooting stating they are eligible to be in possession of a firearm and ammunition (see Terms of Entry below)

**Entry Deadline:** Tuesday 17<sup>th</sup> June at midday

Cancellations: Cancellations must be received via email to <a href="mailto:competitions@nra.org.uk">competitions@nra.org.uk</a> by 8am Wednesday 18<sup>th</sup> June

**Making an entry:** Entries can be made and paid for online via: <u>online.nra.org.uk</u>. A downloadable paper entry form will also be available which can be returned via email or post

**NEW 2025 Programme:** Four competitions run simultaneously, with the best three scores to count towards the Championship total:

- o Advancing Target: A rapid-fire match, with targets advancing from 25m
- Snaps & Rapid: A 2 stage 50m shoot with timed turning targets
- o **Precision:** A 10 shot precision match at 25m
- o **Mini McQueen:** A sniper-style match, shot at 50m, of 10x 3 sec exposures at irregular intervals from a Mini McQueen Castle, using a scoped .22 RF Rifle

Firearms: .22 Ruger Gallery Rifle, which create a small amount of recoil

Shooting Position: All competitions are shot seated, with support from a rest where required

**Scorecards:** Your scores will be recorded on scorecards at the end of each shoot, please ensure these are posted in the boxes on range for the NRA team to process

**When you Arrive:** Please report directly to Melville Range by 9am where the team will issue you with shooting glasses, ear defenders (you may bring your own if you wish), and your scorecards for the day

Dress: Comfortable clothing that is appropriate for shooting is recommended, all ranges are under cover

- Eye protection: is mandatory when on or near the firing point. Loan pairs will be available on the day
- **Ear protection:** All competitors MUST wear ear protection when near or on the firing point of all ranges. Loan pairs or plugs will be available on the day

**Catering:** A selection of drinks and snacks will be available when you arrive, and a buffet lunch will be available on the range during the day for you to enjoy. Please advise of any dietary requirements when booking

**Results:** Results will be displayed on a monitor on range, and will be available online after the event via: www.nra.org.uk/liveresults

**Awards:** NRA Gold, Silver and Bronze Medals are presented for each Competition, and the overall Championship in each the Serving and Veteran Class

**Prizegiving:** Will take place on the range, following the end of shooting

- I have never had a Firearm or Shotgun Certificate refused or revoked. (If you have, please enclose full details in a sealed envelope marked 'Confidential')

- I agree that results of the Competition and classifications may be published on the internet or elsewhere containing my name, competitor number, country, class and score
- I agree that I have read the NSC Range Regulations in regards to the wearing of ear protection, and Appendix III of the NRA Handbook in regards to the wearing of eye protection, and shall not hold the organiser responsible for any injury resulting from non-compliance therewith.
