Programme & Entry Fees:

Saturday 5 th	Falling Plates	£22	£14 Under 25 Team
Sunday 6 th	Methuen Cup	£185	£120 Under 25 Team

Under 25 Discount: 40% discount off entry fee when all members of the team are under 25 years old on the day of the Event

Non-Member Fee: £16.00 per person – applicable to all members of the team. This will not be charged if the individual has already paid for an Individual CSR Imperial Entry

Entry Deadline: Monday 23rd June at midday

Cancellations: Cancellations must be received via email to <u>competitions@nra.org.uk</u> by **8am Thursday 3rd July**. Entries will be fully refunded (or credited) before this time, after this point entries are non-refundable. Credits are valid for 12 months from the date of cancellation

Entry Requirement Summary (See Terms of Entry below for full details):

- ✓ Shooter Certification Card (SCC): All shooters MUST be in possession of their SCC when shooting on NRA ranges. This is awarded to NRA Members, or by a Club Chairperson (of NRA affiliated Clubs) once a shooter has satisfied criteria as to the shooter's ability to use firearms and ammunition safely. If not in possession of an SCC, shooters may apply for a temporary SCC by emailing <u>competitions@nra.org.uk</u>
- ✓ NRA Membership: Membership to the NRA is required to shoot on NSC Ranges, and ensures the individual is covered by the NRA insurance package. Non-NRA members are welcome, but are required to pay an additional Non-Member Fee
- ✓ On the first day of the event you must be aged 14 or over (please contact the event Co-ordinator before entering if this is not the case)

Making an entry: Entries can be made and paid for online via: <u>online.nra.org.uk</u>. A downloadable paper entry form will also be available which can be returned via email or post

Courses of Fire: Conditions and courses of fire are listed in the CSR Handbook which can be found <u>online</u> and in a FREE paperback book available from NRA Reception

Firing Positions: Prone, sitting, kneeling and standing. Para A3.2.22 of the CSR Handbook: A firer who has a physical disability (temporary or permanent) which prevents the use of a position specified in the match conditions may assume the next most difficult position instead. The CRO, RO and the MD must be informed before the start of the match. The following substitutions are among those permitted:

- o a. The sitting position instead of the prone position
- o b. The kneeling position instead of the sitting position
- o c. The standing position instead of the kneeling position
- d. The kneeling unsupported position (either on two knees or on one knee without resting the elbow on the knee) instead of the standing position

Muzzle Energy: Ranges at Bisley use the Danger Area of Pirbright Range, which under MoD requirements state that all firearms used must either have a muzzle energy under 4,500 Joules (3,319 ft lbs), or else be zeroed at 200 yards or on the Bisley Zero Range prior to being used at a longer distance. If your ME exceeds the limit then you must zero your rifle, using the specially designed target, the day before the start of your particular Meeting

Results: Results will be input on the day of the Competition and will be available online: <u>www.nra.org.uk/liveresults</u>

Challenging Results: It is the competitor's responsibility on the day of the competition to ensure that the Wing Officer records their scores correctly. Any challenges of this nature must be made immediately on the day. Following the publishing of scores online competitors have until midday the following day to contact the NRA for errors relating to the digitising of the hand-recorded scores. Falling Plates

Classes:

- o Modern: Any pattern designed from 1955 to present
- Historic: Any pattern pre-1955 design using Iron Sights and chambered in the correct calibre for the firearm as was issued). Bipods not permitted. The course of fire will include a reduced 25 yard rundown, and all rifles must be shot prone unsupported i.e. the use of bipods or a magazine to rest the firearm is prohibited

Modern Rifle

- First Prize: The Challenge Cup, four Nepal Army Standard khukuris presented by RPI Supplies Ltd and four NRA Gold Medals

Historic Rifle

Methuen

Classes:

- Historic Enfield: Any SMLE/ No.4/ No. 5 rifle, service pattern as issued, rest may not be used, trigger weight minimum 4.5lbs, sling as issued
- Practical Optic: Any rifle with optic sights, with no restriction on slings or rests, trigger weight minimum 1.5kg. If any rest is utilised it must remain fitted to the rifle at all times during the match

Awards:

Practical Optic

- o First Prize: The Mauser Trophy and seven NRA Gold Medals
- o Second Prize: Seven NRA Silver Medals
- o Third Prize: Seven NRA Bronze Medals
- Highest Individual: The Kukri Trophy

Historic Enfield

- o First Prize: The Mons Trophy and seven NRA Gold Medals
- o Second Prize: Seven NRA Silver Medals
- o Highest Individual: The Bayonet Trophy

Prizegiving: Prizegiving will take place on range on Sunday 6th July, following the completion of the match

 - I am a member of a Club Approved by the Home Office, the Scottish Ministers or the PSNI and will be shooting as a member of that club and will use any firearm for which I do not hold a Firearm Certificate only in accordance with the applicable exemptions to S1 Firearms Act 1968 (as amended)
- I am not a prohibited person within the meaning of Section 21 Firearms Act 1968 (as amended)
- I have never had a Firearm or Shotgun Certificate refused or revoked. (If you have, please enclose full details in a sealed envelope marked 'Confidential')

Warnings:

- I agree to abide by the rules of the National Rifle Association and I will accept the decisions of the Event Director or the NRA as final
- I agree that results of the Competition and classifications may be published on the internet or elsewhere containing my name, competitor number, country, class and score
- I agree that I have read the NSC Range Regulations in regards to the wearing of ear protection, and Appendix III of the NRA Handbook in regards to the wearing of eye protection, and shall not hold the organiser responsible for any injury resulting from non-compliance therewith.
