**Under 25 Discount:** 40% discount off entry fee for those that are under 25 years old on the day of the Event

Meeting Member Fee: The lowest applicable charge will be applied when entering

- o £30.00 Adult Non-NRA Member
- o £27.00 Serving member of HM Forces, or Over 65, or Overseas
- o £18.00 Under 25
- o FREE Under 21 and entering the Meeting for the first time

Those paying the non-NRA member fee will be provided with a Meeting Membership card in their competitor entry pack. This can be used at the NRA Range Office to book Zero Range or Practice Targets for the duration of the Meeting (subject to supervision approval by the NRA)

## Entry Deadline: Monday 16<sup>th</sup> June at midday

**Payment:** All entries must be paid at point of entry. Overseas competitors may pay when collecting scorecards due to overseas transactions fees. Clubs and Schools can be invoiced by sending us a list of competitor names to <u>competitions@nra.org.uk</u>

**Cancellations:** Cancellations must be received via email to <u>competitions@nra.org.uk</u> by 8am two working days prior to each competition. i.e. if you wish to cancel your entry to the Duke of Cambridge on Sunday 6<sup>th</sup> July, you must send a cancellation via email before 8am Friday 4<sup>th</sup> July. Entries cancelled in time will be fully refunded (or credited), after this point entries are non-refundable. Credits are valid for 12 months from the date of cancellation. Any uncompleted aggregates will also be refunded/ credited as per this policy. Ammunition for un-shot competitions will also be refunded even after the deadline

Entry Requirement Summary (See Terms of Entry below for full details):

- Shooter Certification Card (SCC): All shooters MUST be in possession of their SCC when shooting on NRA ranges. This is awarded to NRA Members, or by a Club Chairperson (of NRA affiliated Clubs) once a shooter has satisfied criteria as to the shooter's ability to use firearms and ammunition safely. If not in possession of an SCC, shooters may apply for a temporary SCC by emailing <u>competitions@nra.org.uk</u>
- ✓ NRA Membership: Membership to the NRA is required to shoot on NSC Ranges, and ensures the individual is covered by the NRA insurance package. Non-NRA members are welcome, but are required to pay an additional Non-Member Fee
- ✓ On the first day of the event you must be aged 14 or over (please contact the event Co-ordinator before entering if this is not the case)

**Making an entry:** Entries can be made and paid for online via: <u>online.nra.org.uk</u>. A downloadable paper entry form will also be available which can be returned via email or post

**Overseas Competitors:** Applications for Visitors Firearms Permits should be made at your earliest opportunity, as it can take a minimum of 3 months to be processed. Please use the Visitors Firearms Permit application form available as a download on the NRA website. Competitors from within the European Community must include a valid European Firearms Pass where applicable

**Firearm Classes:** The definition for F Class Rifles can be found under paragraph 164 of the NRA Handbook. Competitors can compete in either the F-Open or F-TR class

**Muzzle Energy:** Ranges at Bisley use the Danger Area of Pirbright Range, which under MoD requirements state that all firearms used must either have a muzzle energy under 4,500 Joules (3,319 ft lbs), or else be zeroed at 200 yards or on the Bisley Zero Range prior to being used at a longer distance. If your ME exceeds the limit then you must zero your rifle, using the specially designed target, the day before the start of your particular Meeting

**Target Rifle ID (TRID):** This is a unique index number that allows us to match up your scores from multiple Imperial Meetings. Your TRID is listed on your membership profile and on our online booking website: online.nra.org.uk/customer/info. If you do not have a TRID please leave the field blank and one will be assigned

#### **Eligibility:**

- **Clubs:** You may list up to two Clubs on your entry form, the Primary one will be listed on all prize lists and Secondary can be referenced by captains for team selection
- **Country:** Please state the Country you are eligible to shoot for even if you do not intend to shoot in international matches, as this is required to calculate your eligibility into certain aggregates and special duty exemptions and so we can fly your flag at Bisley!

**Courses of Fire:** Conditions and courses of fire are listed in the NRA Handbook which can be found <u>online</u> and in a paperback book available to purchase from NRA Reception for £13.50

Ammunition: Competitors must supply their own ammunition, which may include handloads

**Squadding:** Once entries have closed, your entries will be allocated (squadded) to a specific time slot during the Meeting which will be communicated to you via email. We aim to squad F-Open and F-TR competitors in different details/ targets

Alternative Shooting Position: A competitor who is unable to shoot prone may apply upon entry to shoot from a bench (see paragraph 134b of the NRA Handbook). Competitors must provide their own bench in accordance to paragraph 156 of the NRA Handbook:

- The weight of the rifle must be borne fully by the body
- The butt may be supported in the shoulder but must not rest on the table or on an artificial support of any kind
- The competitor, table and other equipment together, must not take up more than their allotted space on the firing point
- o The table must be of conventional design and be capable of being moved and erected by the competitor

**Mentors:** Any competitor, particularly those entering for the first time, can benefit from mentoring by an experienced competitor. To request this service please complete the appropriate box on the entry form. You will be contacted prior to the Meeting with further details. Any suitably experienced competitors who would like to volunteer to be a mentor should contact the Shooting Division via <u>competitions@nra.org.uk</u>

**HME ZEROING:** Before you can collect your scorecard pack, you must Zero your firearm and bring the zeroing card to the NRA Reception

When you Arrive: Please report to NRA Reception where your competitor pack will be ready for you to collect

**Scorecards:** Affix the corresponding squadding sticker (provided in your scorecard pack) to the top of each scorecard. Please record your scores in the top half of the scorecard, and the scores of the person you are keeping register for in the bottom half. The person you keep register for is the person on your target who shoots immediately after you. Once scores have been agreed please sign the card and place it into the scorecard box (on the Range Officer table) before leaving the range

Results: Results will be input on the day of the Competition and will be available online: www.nra.org.uk/liveresults

**Challenging Results:** It is the competitor's responsibility on the day of the competition to ensure that scores are written down correctly before submitting cards into the scorecard box

 Provisional results are printed on white paper and attached to the scoreboards to the side of the Main NRA Building. After results go final and are printed on yellow paper. If you wish to make a challenge to the digitising of your results you must do so whilst the results are Provisional **Prizelists:** Prize Lists are displayed periodically throughout the Meeting outside the Main NRA building. After the Meeting they will be published on the NRA website, and made into a CD and paperback book typically available in January the following year. **NEW for 2025:** We will not be taking pre-payments for these items before or during the Meeting, they will be made available to purchase once made following the Meeting

Awards: Details of the specific match awards are listed in the NRA Handbook

**Prize Giving:** Presentation of all medals and trophies will take place at 6pm on Sunday 6<sup>th</sup> July Canadian Pavilion following the completion of the team competition. We have arranged a BBQ buffet to be served from 5.30-6.30pm. The Canadian Pavilion boasts a number of recent refurbishments, including to the bar and function space, whilst still maintaining its fantastic history. Tickets are **£18 per person** and include: Gourmet angus beef & chicken burgers served in brioche buns, North American steamed hot dogs in rolls, a selection of salads and desserts, and great hospitality!

**Firearms Usage:** The NRA is required to keep a record of firearms used by competitors as required by the Firearms (Amendment) Acts 1997. Following a Competition please go to your online profile and update your firearms usage: <u>online.nra.org.uk/customer/firearmusages</u>

#### **Terms of Entry:**

- I agree I meet the entry requirements as stated in these Event Notes
- I confirm that the information given on the attached Entry form is true, complete and accurate

#### Access to firearms:

- I meet at least one of the following conditions that legitimises my access to firearms:
  - o I am an individual member of the NRA (or temporary 'Meeting Member' by paying the Non-Member Fee)
    - I hold a Firearm Certificate or GB Visitor's Firearm Permit permitting me to use, for target shooting, the firearms that I shall fire in this event
    - I am a member of a Club Approved by the Home Office, the Scottish Ministers or the PSNI and will be shooting as a member of that club and will use any firearm for which I do not hold a Firearm Certificate only in accordance with the applicable exemptions to S1 Firearms Act 1968 (as amended)
- I am not a prohibited person within the meaning of Section 21 Firearms Act 1968 (as amended)
- I have never had a Firearm or Shotgun Certificate refused or revoked. (If you have, please enclose full details in a sealed envelope marked 'Confidential')

### Warnings:

- I agree to abide by the rules of the National Rifle Association and I will accept the decisions of the Event Director or the NRA as final
- I agree that results of the Competition and classifications may be published on the internet or elsewhere containing my name, competitor number, country, class and score
- I agree that I have read the NSC Range Regulations in regards to the wearing of ear protection, and Appendix III of the NRA Handbook in regards to the wearing of eye protection, and shall not hold the organiser responsible for any injury resulting from non-compliance therewith. Any mandatory details will be contained within these Event Notes
- I understand that if I have debts to NRA or NSC Ltd over 90 days outstanding, entry to this event will be restricted until these have been settled in full
