Thursday 16<sup>th</sup> – Sunday 19<sup>th</sup> July 2026

**Grand Aggregates: FREE.** Entry is automatic when booking all parts of the relevant aggregate:

**GRCF, GRCF Classic, GRSB:** 25m Precision, Advancing Target, America Match, Granet, Imperial Silhouette, Multi-Target, Timed & Precision 1

**LBP, LBR:** 25m Precision, Advancing Target, Granet, Multi-Target, Timed & Precision 1

**MLR:** 25m Precision, Advancing Target, Granet

**Gallery Rifle Aggregate: FREE.** In GRCF, GRCF Classic, GRSB, LBP, LBR, MLR. Entry is automatic when entering 25m Precision and Granet in any one firearm class

**Team Competitions: £5 per team.** Scorecards must be purchased separately

**Under 25 Discount:** 40% discount off entry fee for those that are under 25 years old on the first day of the Event

**Non-Member Fee:** £17.00

**Entry Requirement Summary** (*See Terms of Entry below for full details*):

- ✓ **Membership:** This competition is open to NRA Members. Shooters from other Home Office Approved Clubs are welcome but are required to pay the Non-Member Fee
- ✓ **Shooter Certification Card (SCC):** In the firearm type you are due to compete with. If not in possession of a suitable SCC, shooters should email [competitions@nra.org.uk](mailto:competitions@nra.org.uk) before entering to apply for a temporary card
- ✓ **Age:** On the first day of the event, you must be aged 14 or over - please contact the event Competitions Team before entering if this is not the case

**Entry Deadline:** Monday 13<sup>th</sup> July at midday

Entries can be accepted during the Meeting, and are subject to range availability

**Cancellations:** Cancellations must be received via email to [competitions@nra.org.uk](mailto:competitions@nra.org.uk) by **8am two days prior to the squadded session**. Entries will be fully refunded (or credited) before this time, after this point entries are non-refundable. Credits are valid for 12 months from the date of cancellation. Any entries made after the deadline can be refunded if returned to reception during the meeting

If you are been unable to shoot an events due to an event management issue (such as targetry failure), you can request a Refund/Credit form at the main NRA reception during the Meeting. The requisite scorecards must be included with the form, and if approved you will be notified via email of credits due

**Making an entry:** Entries can be made and paid for online via: [online.nra.org.uk](http://online.nra.org.uk). A PDF version of the entry form will also be available from the webpage, which can be returned via email or post

**Gallery Rifle ID (GRID):** This is a unique index number that allows us to match up your scores from the multiple NRA Competitions. Your GRID is listed on your membership profile and on our online booking website:

[online.nra.org.uk/customer/info](http://online.nra.org.uk/customer/info). If not yet in possession of one, this will be issued when you make your entry

**Unlimited Matches:** Your single highest scorecard in each Unlimited event will determine your position on the results list

**Re-Shoots:** All Unlimited Competitions can be re-shot as many times as you wish. Re-shoot tickets can be purchased as part of your online entry, or from the NRA Reception during the Meeting. Any un-used tickets can be refunded if returned to NRA Reception by the end of the Meeting

**Courses of Fire:** Conditions and courses of fire are listed in the GR&P Handbook which can be found [online](#) or in a paperback book available for FREE from NRA Reception

**Firearms:** Please refer to the match condition as to which firearm types can contest each match

**Muzzle Energy:** Ranges at Bisley use the Danger Area of Pirbright Range, which under MoD requirements state that all firearms used must either have a muzzle energy under 4,500 Joules (3,319 ft lbs), or else be zeroed at 200 yards or on the Bisley Zero Range prior to being used at a longer distance. If your ME exceeds the limit then you must zero your rifle, using the specially designed target, the day before the start of your particular Meeting

**Alternative Shooting Position:** When entering a Meeting, a competitor who has a physical disability (temporary or permanent) which prevents the use of a position specified in the event conditions can apply via the entry form to the Meeting Director for permission to use an alternative position. Subject to approval the competitor will normally be allowed to adopt the next most difficult position for the event

**Squadding:** Unlimited Matches are not squadded and competitors have to report to the range and speak with the RO team who will advise on availability. A programme of events is available online, and offers a guide as to when each match should be contested

#### **Team Entries:**

- Entry to a team event provides the team with a cover card and 4 nomination stickers
- Individuals must purchase their Unlimited Scorecard separately, which can be used for Individual and/ or Team use. To be used as a Team scorecard, the shooter must nominate a scorecard prior to shooting by placing a nomination sticker clearly on the card
- Once the shoot has been completed, scorecards must be posted into the scorecard box immediately

**Results:** Results will be input on the day of the Competition and will be available online: [www.nra.org.uk/liveresults](http://www.nra.org.uk/liveresults)

**Challenging Results:** It is the competitor's responsibility on the day of the competition to ensure that scores are written down correctly before being signed by the Range Officer and posted in the scorecard box. Any challenges to scores before they are signed off must be made immediately to the Range Team on the day

- o During the Meeting provisional results will be periodically published online
- o Once the Meeting has finished no edits can be made for competitor errors on the scorecards. Following the publishing of scores online competitors have until midday on the Thursday of the following week to contact the NRA for errors relating to the digitising of the hand recorded scores. **Awards:** NRA Medals are awarded to each Competition, in each firearm class, for each classification group, subject to Prize List D of the NRA handbook:

- o 2+ Entries: Gold Medal
- o 6+ Entries: Gold and Silver Medal
- o 11+ Entries: Gold, Silver and Bronze Medal

**Imperial Grand Master:** Gold, silver and bronze standard scores are set for most Unlimited events at the Imperial Meeting (see the GR&P Handbook for more details). Once a competitor achieves a given standard, they will receive the following amount of points:

- o Gold standard: 5 points
- o Silver standard: 3 points
- o Bronze standard: 1 point

A competitor will receive a Grand Master Medal (Standard NRA Medal) after the Meeting on accumulating the following amount of points:

- o Gold Grand Master: 30 points
- o Silver Grand Master: 25 points
- o Bronze Grand Master: 20 points

**Prizegiving:** Gold medals, and any accompanying trophies will be presented at the Main Imperial Prizegiving on Saturday 25<sup>th</sup> July at 18:00 in the marquee on Exhibition Lawn

**Firearms Usage:** The NRA is required to keep a record of firearms used by competitors as required by the Firearms (Amendment) Acts 1997.   - I am a member of a Club Approved by the Home Office, the Scottish Ministers or the PSNI and will be shooting as a member of that club and will use any firearm for which I do not hold a Firearm Certificate only in accordance with the applicable exemptions to S1 Firearms Act 1968 (as amended)
- I am not a prohibited person within the meaning of Section 21 Firearms Act 1968 (as amended)
- I have never had a Firearm or Shotgun Certificate refused or revoked. (If you have, please enclose full details in a sealed envelope marked 'Confidential')

**Warnings:**

- I agree to abide by the rules of the National Rifle Association and I will accept the decisions of the Event Director or the NRA as final
- I agree that results of the Competition and classifications may be published on the internet or elsewhere containing my name, competitor number, country, class and score
- I agree that I have read the NSC Range Regulations in regards to the wearing of ear protection, and Appendix III of the NRA Handbook in regards to the wearing of eye protection, and shall not hold the organiser responsible for any injury resulting from non-compliance therewith. Any mandatory details will be contained within these Event Notes
